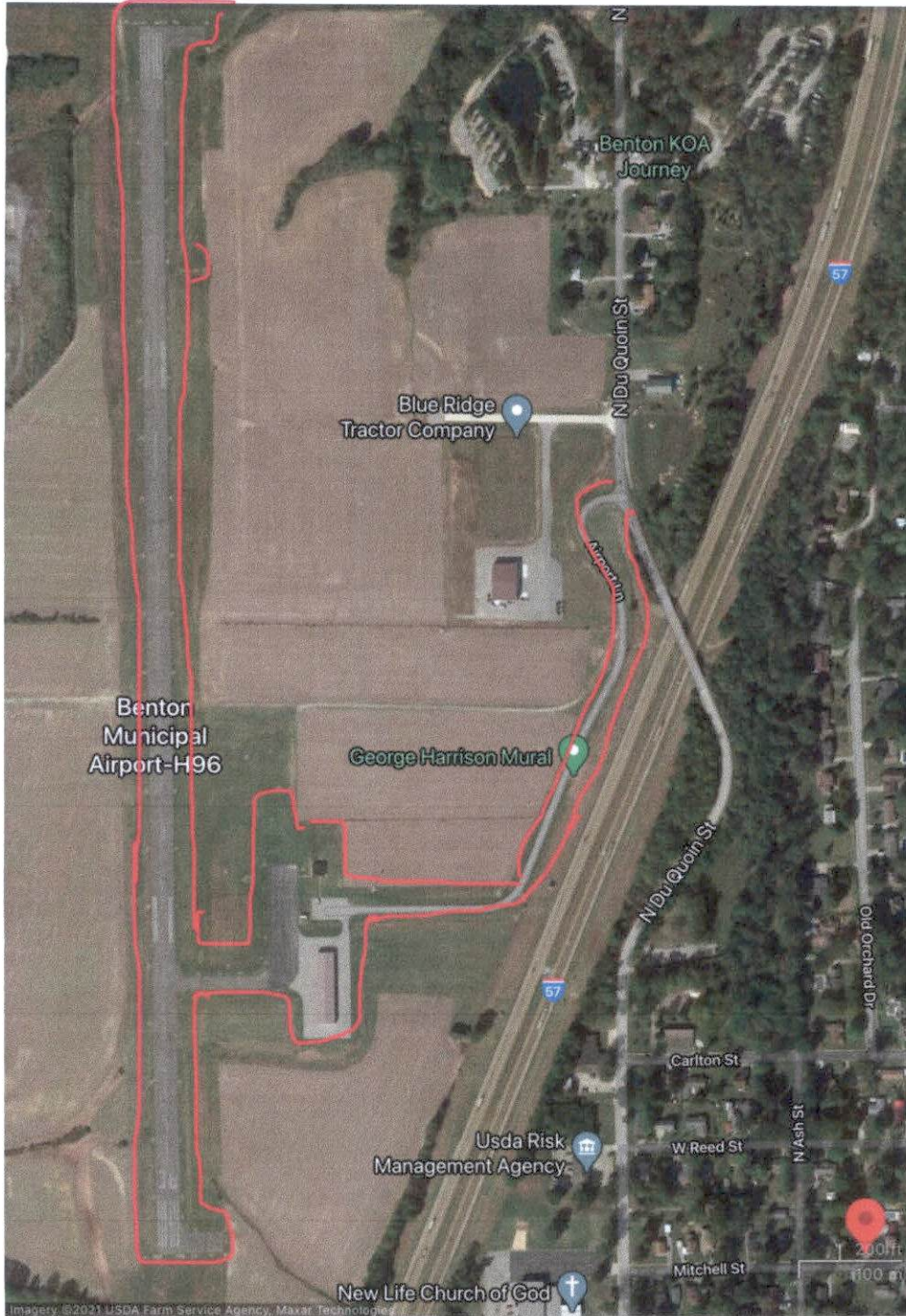
## NOTICE TO BID

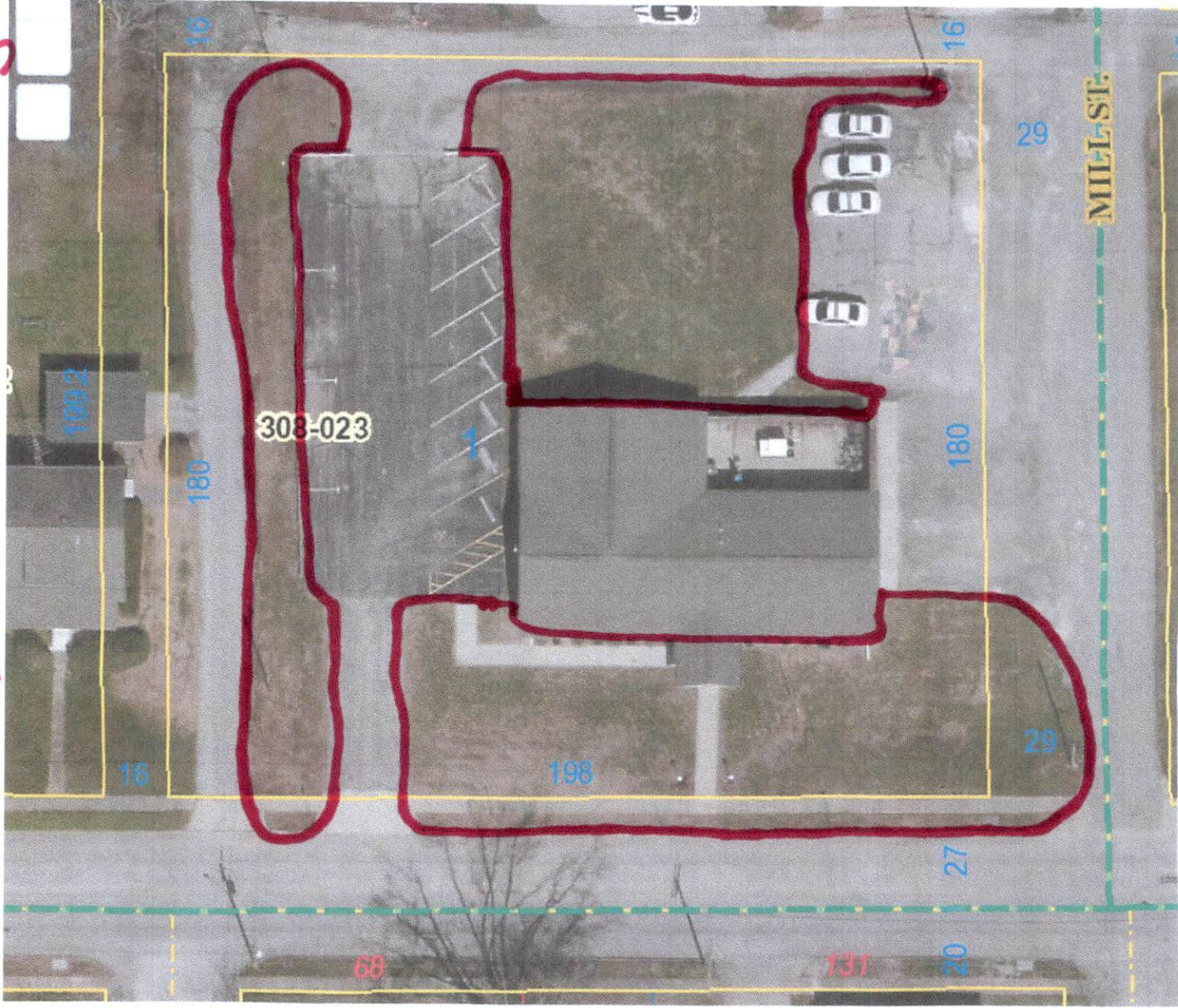

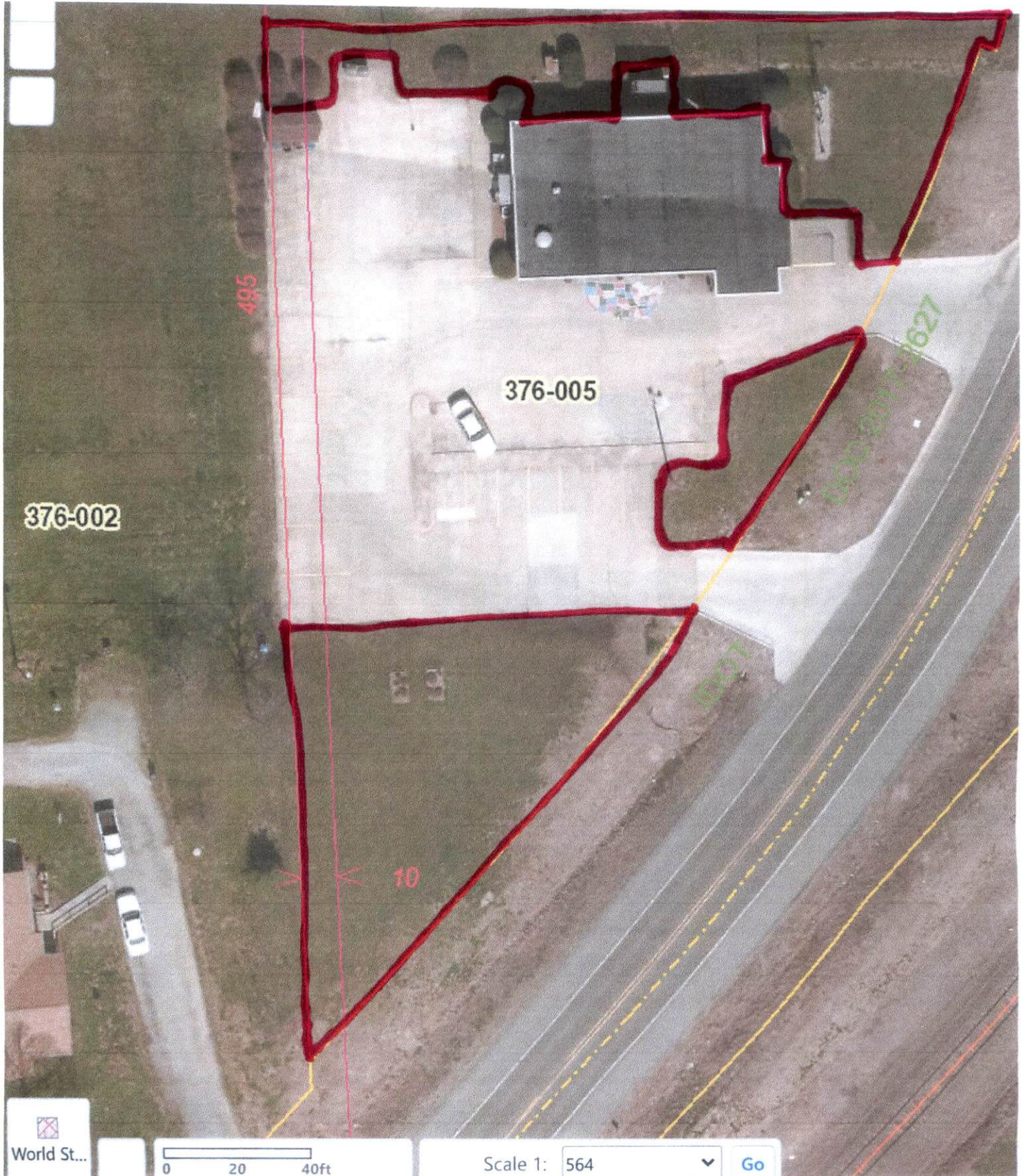
